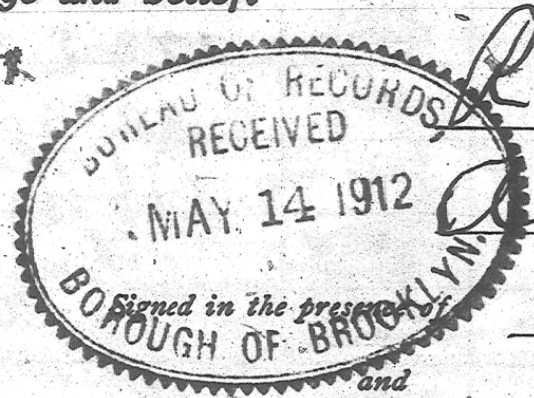

First. My place of residence is 812 Rutter Ave, City of New York, Borough of Brooklyn, N. Y.

Second. My occupation is grocer.

Third. I was born on the 10 day of March, anno Domini 1877, at Moscow, Russia.

Fourth. I emigrated to the United States from Russia Germany, on or about the 8 day of August, anno Domini 1903, and arrived in the United States, at the port of New York, on the 18 day of August, anno Domini 1903, on the vessel Koenig Louise.
(If the alien arrived otherwise than by vessel, the character of conveyance or name of transportation company should be given.)

Fifth. I declared my intention to become a citizen of the United States on the 3 day of October, anno Domini 1909, at New York City, in the Eastern Court of US Southern District NY.

Sixth. I am married. My wife's name is Rebecca Thomer, 25 yrs She was born in Russia, and now resides at 812 Rutter Ave, City of New York, Borough of Brooklyn, N. Y.

Seventh. I am not a disbeliever in or opposed to organized government or a member of or affiliated with any organization or body of persons teaching disbelief in or opposed to organized government. I am not a polygamist nor a believer in the practice of polygamy. I am attached to the principles of the Constitution of the United States, and it is my intention to become a citizen of the United States, and to renounce absolutely and forever all allegiance and fidelity to any foreign prince, potentate, state, or sovereignty, and particularly to Scholarst Emperor of the Russian, of whom at this time I am a subject, and it is my intention to reside permanently in the United States.

Eighth. I am able to speak the English language.

Ninth. I have resided continuously in the United States of America for the term of five years at least, immediately preceding the date of this petition, to wit, since the 18 day of August, anno Domini 1903, and in the State of New York, continuously next preceding the date of this petition, since the 18 day of August, anno Domini 1903, being a residence within this State of at least one year next preceding the date of this petition.

Tenth. I have not heretofore made petition for citizenship to any court. (I made petition for citizenship to the _____ Court of _____ at _____, on the _____ day of _____, anno Domini 1____, and the said petition was denied by the said Court for the following reasons and causes, to wit, _____, and the cause of such denial has since been cured or removed.)
